The Pasquotank County Board of Commissioners met today in a regular meeting on Monday, August 15, 2016 in Courtroom C in the Pasquotank County Courthouse.

The meeting was called to order at 7:00 PM by Vice-Chairman Cecil Perry. He welcomed everyone present. Commissioner Bettie Parker gave the invocation and Commissioner William Sterritt led in the Pledge of Allegiance to the American Flag.

She also served as captain on both her volleyball and basketball teams.

Commissioner Parker presented Ms. Banks a certificate of excellence for outstanding academics and leadership, as well as a check for \$1,000.

Ms. Mattie Banks stated that she is honored to be here tonight. She thanked the Board for the opportunity to receive the scholarship award and said she would like to especially acknowledge Commissioner Parker for nominating her for the award and scholarship. c. Approval of Family Subdivision Request FS 16-04 by Ophelia Meads

Staff recommends approval of Family Subdivision Request FS 16-04 by Ophelia Meads. Ms. Meads is requesting to create a 1.0 acre gift lot for her granddaughter, Brandy Meads Wooten, in accordance with Article 5, Section 303 of the Pasquotank County Subdivision Ordinance. A total of 143.57 feet of road frontage is provided to the parcel off of Salem Church Road. Documentation that the plat qualifies as a family subdivision has been provided and an improvement permit has been issued for a septic system. Staff advises that the request meets the minimum requirements for a family subdivision and recommends approval.

Community Meeting on Race Relations – Local pastors Reverend Michael "Hipp" Barclift and Reverend Chip Broadfoot organized and led the first community meeting to begin a dialogue concerning racial relations and what can be done, as a community, to improve them. Chairman Winslow and I, along with approximately 30 other participants attended. Attendees represented faith-based, business, education, non-profits and law enforcement. Captain John Young, EC Police Department, informed attendees of the many initiatives by the EC Police Department to work with the community to improve relationships. We were divided into four groups and all were asked to consider what we see in our community that needs improvement and how we might begin to work to improve relationships. Attendees agreed that this is not merely a law enforcement problem. The group believes that to better racial relationships will require a collective effort by churches and business leaders. The group plans to meet again in the very near future and will ask additional individuals to attend.

Amazon Wind Project – Craig Poff emailed me this morning to inform me that the last of the 104 wind turbine foundations was poured this past weekend. The turbine erection is speeding up with additional cranes, night shifts and favorable weather conditions.

7. <u>REPORTS FROM COMMISSIONERS</u>:

Commissioner Sterritt attended the Community Relations Commission meeting on Monday. He stated that he has invited two members of the CRC to come to the County Commissioners meeting on September 19th to provide an update on their activities.

Commissioner Meads recently volunteered to serve at the annual Coast Guard Day. He stated the turnout was great and it was a nice event.

Commissioner Dixon reported that the charter school has added two additional grades. Currently, there are 240 students enrolled. They have outgrown the Gilchrist Building and are now being housed in Moore Hall. He said they continue to get great reviews from the students.

Commissioner Parker attended the NCACC Conference from August 11th through the 14th. She said it was very interesting and she really enjoyed herself. She went to many sessions and shared a couple with the Board. She said not only was Mattie a winner at the conference, but she herself was a winner also. She stated that four people out of approximately five hundred won a basket full of goodies and she happened to be the first name drawn.

Vice-Chairman Perry attended the NCACC Conference as well. He said he attended a breakfast sponsored by the Wooten Company and received information regarding available funding. He attended a session regarding mental health and jails. He stated that 4-H members from all over North Carolina participated in the conference. He said they voted on new officers and Commissioner Fred McClure from Davidson County was voted in as the new President of the NCACC.

Commissioner Parker said Dyhmel Ferebee, a local youth from the Boys and Girls Club, represented Pasquotank County at the conference. She said she attended the youth breakfast and it was very exciting and inspiring that a young man and his mother from our county were there participating.

Motion was made by Jeff Dixon, seconded by Bettie Parker to adjourn the meeting. The motion carried unanimously and the meeting was adjourned at 7:26 PM.
