## C. <u>Hunting with Dogs</u>

On August 2, 2021, the Special Projects Committee voted to take no action following a discussion on Hunting with Dogs. A Commissioner requested that we place the item on the agenda for consideration/discussion by the full Board. Some counties, such as Chowan and Perquimans, require hunters to get written permission from property owners prior to hunting on the property owner's land. The Landowner Protection Act, which was enacted in 2011, provides similar protection for landowners who properly post their property against trespassing without permission. Sergeant Owens from the NC Wildlife Resources Commission will be in attendance to answer any technical questions.
